Welcome to our Privacy Policy—your privacy is critically important to us.

It is RD Quilting's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://rdquilting.com/> (hereinafter, "us", "we", or "<https://rdquilting.com/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the website and does not apply to our collection of information from other sources.

This **Privacy Policy**, together with the **Terms and Conditions of Use** posted on our website, sets forth the general rules and policies governing your use of our website. Depending on your activities when visiting our website, you may be required to agree to additional terms and conditions.

Website Visitors

Like most website operators, RD Quilting collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. RD Quilting's purpose in collecting non-personally identifying information is to better understand how RD Quilting's visitors use its website. From time to time, RD Quilting may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

RD Quilting also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged-in users and for users leaving comments on <https://rdquilting.com/> blog posts. RD Quilting only discloses logged-in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

Gathering of Personally-Identifying Information

Certain visitors to RD Quilting's websites choose to interact with RD Quilting in ways that require RD Quilting, to gather personally-identifying information. The amount and type of information that RD Quilting gathers depend on the nature of the interaction. For example, we ask visitors who sign up for a blog at <https://rdquilting.com/> to provide a username and email address.

Security

The security of your personal information is important to us, but remember that no method of transmission over the internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

Advertisements

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by RD Quilting and does not cover the use of cookies by any advertisers.

RD Quilting may use uses Google Ads, Facebook, Bing and others for remarketing

RD Quilting uses remarketing services to advertise on third-party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an inquiry. This could be in the form of an advertisement on the Google search results page or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone's past visits. Aggregated Statistics

RD Quilting may collect statistics about the behavior of visitors to its website. RD Quilting may display this information publicly or provide it to others. However, RD Quilting does not disclose your personally-identifying information.

Cookies

To enrich and perfect your online experience, RD Quilting uses what is commonly known as "cookies." similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. RD Quilting uses cookies to help identify and track visitors, their usage of <https://rdquilting.com/>, and their website access preferences. RD Quilting's visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using

RD Quilting's website, with the drawback that certain features of RD Quilting's website may not function properly without the aid of cookies.
